GALILEE REGIONAL CATHOLIC PRIMARY SCHOOL DIGITAL TECHNOLOGY POLICY

Dear Parents and Carers,

At Galilee, we recognise the need for students to be safe and responsible users of Digital Technologies, both at school and home. The world our students live in is increasingly being shaped by their ability to acquire, communicate, access and manipulate information using a range of technologies.

We believe that teaching students about safe and responsible behaviour while online is essential and best taught in partnership with parents and guardians.

For this reason, we request that parents and guardians of the students at Galilee work collaboratively with us to encourage safe and responsible online use at home. This agreement covers your child for the duration of their time at Galilee. We will notify you of any changes made and send you an update at the beginning of each year. You will only need to agree to the contract once.


Before students commence using technology at Galilee, we ask that as a family you read through this **Digital Pack**. This pack contains two policies for Galilee, including:

- **ICT and Technology User Agreement** - This policy includes the school's expectations for technology use, both in the classroom and at home.
- **Class Dojo Agreement** - Galilee will be using Class Dojo to create Student Portfolios. This will allow parents to have access to samples of students' work throughout the year.

As you read these policies with your child, we ask you to remind them that students must only use their email accounts for **learning purposes only**, including messaging their teacher at home about Home Learning or uploading homework tasks to ClassDojo or Google Classroom. Students should not use their Gmail accounts to message other students about general conversations. (i.e. "How was your weekend?")

Students who do not follow this protocol may have their Google account deactivated, and their use of technology at school revoked.

We also encourage you to discuss social media with your child when the time is right for you. The **legal required age for registering for any form of social media is 13 years or older.**

ICT and Technology User Agreement

Please read through the policy with your child to be sure that they understand the details and implications. This policy applies to all students attending Galilee Regional Catholic Primary School.

Student Expectations:

As a safe and responsible user of the school's technology I will help keep myself and other people safe by following these rules:

- I will use ICT for learning purposes as directed by my teacher.
- I will respect all school ICT and treat ICT equipment/devices with care. I will report any breakages/damages to a staff member as soon as possible.
- I understand that I can only use the Internet, email or other networked technologies when a teacher gives permission and there is staff supervision at school.
- I will keep my password private and not let anyone else log in with my username. Trusted adults (parents, staff) may however log in on my behalf.
- I will not use any form of ICT to find, create or send material and activities which might upset, offend, harass or humiliate me or anyone else. This includes taking photos of others without permission. (Repeated incidence of such behaviours is considered bullying).
- I will not intentionally click on online advertising.
- I will not use search engines to look for things that are inappropriate. This includes anything that is rude, violent or uses unacceptable language and/or breaks any of our school rules
- The Galilee school uniform (or mention of Galilee) is not to be posted anywhere on the internet
- I will not use ICT to share anyone's personal details or images (including my own). This includes addresses, telephone numbers, full names and images.
- I will seek teacher permission before uploading any content to websites
- I will not connect any device (such as a USB, camera or phone) to school ICT or download and run any programs or software (this includes games) without the permission of my teacher.

- I will keep my own device or equipment at home and not bring it to school unless I have been given special permission by my teacher or parents (this includes devices such as iPods, iPads, cameras, portable video game consoles or similar).
- I will keep my mobile phone/smartwatch on silent / turned off and handed in to my teacher when I am on school grounds, or on an excursion during school hours and acknowledge that bringing such a device is at my own risk.
- I will seek permission from individuals before taking photos, recording sound or videoing them (including teachers).
- I will not try to edit or change any part of my Google Account, this includes adding extension or themes on Google Chrome

If I find anything that is rude, violent or in some other way inappropriate while using any form of ICT, I will follow class guidelines and:

STOP ... what I am doing

BLOCK ... it by minimising or closing my screen so that others can not see it

TELL ... a teacher or closest adult straight away.


I will also follow the Stop, Block and Tell rules:

- if I accidentally access someone else's private information
- if someone does something using technology that makes me feel upset or uncomfortable
- if I feel that the safety of other students at the school is being threatened

Behaviour Expectations:

Students will:

- follow teacher directions at all times when using technology
- ensure that they leave any form of technology (iPad, Chromebook, Desktop Computer) in the same way it was found
- only use designated technology, directed by a teacher, unless in a collaborative environment with teacher permission

- only use their own username and password to login. If they feel their login details have been compromised they must tell a teacher or adult immediately.
- use copyright free material only, or their own original material - images, video, music etc
- not use material that is made by somebody else without including a bibliography or citation

Parent / Guardian Expectations:

- I understand the school will provide adequate supervision and that steps have been taken to minimise risk of exposure to unsuitable material.
- I agree to allow my child to use the internet at school for educational purposes only. I have discussed the scenarios, potential problems and responsible use of the internet with him/her.
- I agree to allow my child to correspond with others using the gmail account provided by the school for grades 3 - 6, for learning purposes only.
- I have also discussed the legalities of social networking sites with my child such as, but not limited to Facebook, Instagram, TikTok, Reddit , Omegle, Discord and X. I understand that social media accounts are not recommended by any staff member from Galilee Regional Catholic Primary School for any current student (**13 years and above is the legal minimum age for these sites, and that is often considered to be too young**).
- Under no circumstances is the school gmail account allowed to be used to register for any social media, website or application at home or school, unless approved by the school.
- I understand that it is my / our responsibility as parent(s) to supervise my child when using technology at home.
- I understand that new applications and/or websites may be installed and used throughout the school year for learning purposes
- I will contact the school if there is anything here that I do not understand. If there is a situation which concerns me, I will contact Amy Burns (Acting Principal) aburns@gsm.vic.edu.au or Richard Harding (Deputy Principal) rharding@gsm.vic.edu.au

Please note that breaking any of the above expectations may result in ICT privileges (use of technology, Google Accounts) being revoked.

Class Dojo Agreement


ClassDojo is a classroom communication app used to share reports between parents and teachers. Teachers track student behaviour and upload photos or videos to allow for real-time feedback to parents about their child's learning.

The Portfolios will vary depending on the Year Level and class that your child is in. For example, in the Junior Year Levels (Years Prep - 3) students will share a class device to update their portfolios, or may be updated by their classroom teacher. In Middle and Senior Levels (Years 4 - 6), students will independently update their portfolio, while being supervised by their classroom teacher. This also includes their Specialist Lessons. All pictures that are uploaded to the ClassDojo are only visible to the Galilee community, as all parents require a unique sign-in code before they can view their child's portfolio. Portfolio posts are only visible to the teacher, student whose account they are posted onto and family members connected to that student's account.

The work that is submitted to a student's portfolio has been checked by the teacher. Although it may contain errors or mistakes made by the student, overly correcting a student's work for grammar and punctuation may detract from the ideas and brilliance exhibited by the student. Over correction can be demoralising for a student.


The purpose of the portfolio is to demonstrate and share samples of work in order to continue the conversation of learning at home.

Using Student Portfolios comes with the following expectations:
